Treasurer's Report

The outgoing Reading Carnival Committee reported at the 2002 AGM that the financial position was a healthy one, it soon became clear to the newly elected committee that this was not so.

The situation can be summarised as follows:

- Despite reassurances at last years AGM, the requested report to Southern & South East Arts on the 2002 carnival was not completed. This resulted in the remaining £3,500 of a £6,500 grant from Southern and South East Arts being withheld.
- Outstanding debts totalling £650 from The Unity Sports Association & Fruit Bat could not be collected, and were therefore written-off.
- The financial statement for 2002 showed a total of £2664 'Cash at bank and in Hand' with no outstanding creditors. However, the report of no creditors was erroneous. A number of cheques were presented after the 2002 AGM, and before the signatories to the account where changed at the bank. When the signatories were changed, the account balance stood at £1130.

The balance sheet for 2001/02 has therefore been restated to show the difference and a copy of the original balance sheet is included for information (Appendix A).

The 2003 committee were unable to obtain arts funding for this year's event, and income consisted of a grant from Reading Borough Council (RBC) and stall fees. With limited income, it was important that we focused on minimising the costs in staging Carnival 2003. We successfully made savings in the following areas:

- A local church provided Car Park Attendants, and cleaned up Prospect Park for a donation to their church funds. This saved £1500 compared to the 2002 costs.
- Radio 107 & Reading Evening Post assisted with free advertising and publicity. RBC met postage costs and provided photocopying facilities saving £ 900
- Asda provided refreshments for the hospitality tents, saving £600.

Unfortunately, the carnival dance made a loss due to the low number of tickets sold. This was because of the short time that was available for publicity. However, the committee felt that it was important that the carnival dance was held after last year's cancellation.

We have ended the year with a slight profit to build on for next year. For 2004, we are actively looking at increasing sponsorship, both monetary and in kind.
